- what is the legalities of having drainage off-site: The Council are under the impression that drainage systems should be on the landowners site?

Description Erection of detached dwelling with associated parking and landscaping Location Land NE Of Valley View Callington Road Harrowbarrow PL17 8AZ

Applicant Mr And Mrs P Becker

Proposal The Parish Council continue to object to this application. Despite the amendments the Parish Council feels the proposal is still too large and will negatively impact on:

- Loss of light, vehicular access (on a narrow road),
- impact on the WHS,
- previous planning policy,
- overshadowing/loss of outlook,
- layout/density of building especially design and visual appearance the site is directly opposite miners' cottages.

It is felt that the proposal still contravenes Policies 12 (design) and 24 (historic environment) of the Cornish Local Plan Strategic Policies 2010-2030 and the following paragraphs of the 2012 National Planning Policy Framework (paragraph 128):

- Section 7 Requiring Good Design
- Section 11- Conserving and Enhancing the Natural Environment
- Section 12 Conserving and enhancing the Historic Environment (proposed: Cllr Rooker, seconded: Cllr Beech (3 abstentions)
