85/18 NEW CORRESPONDENCE

Jeremy Lawrence

Mr Lawrence emailed the Parish Council on 30-03-18 to express concern about a new business "Wild Country Experiences" operating from the White Hart Inn, Chilsworthy.

Virginia Grose also spoke on this matter.

Cllr Irons feels this new venture is inappropriate for a village pub and there will be issues with parking and potential obstruction of emergency vehicles if it is successful. Cllr Greenwood also feels it is an inappropriate setting for such activities as clay pigeon shooting, falconry etc. Mr Lawrence has reported concerns to Trading Standards, Cornwall Council and the RSPCA. The Clerk has also reported it to Planning Enforcement.

The Parish Council hope to hear back from Planning Enforcement and asked Ms Grose to keep them informed.

86/18 STANDING ITEM: CLERK'S INFORMATION

The Clerk will be attending training on the new GDPR (General Data Protection Regulations) regulations and she is also undertaking the end of year accounts.

87/18 STANDING ITEM: CALSTOCK FLOOD DEFENCE

Cllr Tinto had sent press releases out, as approved by the Clerk, prior to his visit overseas.

Cllr Kirk reported that it may be possible to set a 106 agreement up if planning permission is granted for the EA to include maintenance of the riverside path. She also feels there has been no consultation with the Rivers Trust about this proposal and the river itself needs an assessment as well as the riverbank. Without a definitive plan it remains difficult to fully assess the likely impact.

93/18 WOODLAND WAY CENTRE

Cllr Greenwood reported that the Trustees are applying for funding from various sources. There is now a wi-fi connection. Regarding the outstanding money, Cllr Kirk reported that the Localism Officers have met with Cornwall Housing who were un-cooperative. As a result, they have sent the issue up to the Strategic Director for Neighbourhoods in Cornwall Council.

94/18 CORNWALL COUNCIL REPORT – CLLR KIRK

Stadium for Cornwall

Cornwall Council will debate this issue next week. There is a £6million deficit in funding. The Parish Council opposed this project initially. Discussion ensued: some concerns were raised about the stadium's location, small audience capacity and whether it is inclusive enough. Other Councillors felt it would be beneficial for sport in Cornwall and would enable the football team and rugby team to progress and that poor facilities hold the County back. The general feeling seemed to be that there is support in principle for a stadium to enable the sports team to gain financial support and move forward, but it seems a lot of money for Cornwall Council to fund when health and social care budgets are being cut.

Bridge View Nursery Planning Application

This has been held up by an enquiry into a badger's sett and questions about highways. No recommendation has yet been made. Cllr Kirk remains in contact with the Planning Officer, Dean Mutton.

<u>A390</u>

Cllr Kirk is due to meet with the portfolio holder for Transport next week to discuss the problems of the A390 and of the air quality issues in Gunnislake.

Tamar Valley Line

The Consultant's report on the economic value of the Tamar Valley Line is now complete and is very positive; making particular mention of Gunnislake and Calstock.

Woodland Way Walkabout

Cllr Kirk and Kim Williams did a walk about in Woodland Way last week. Cllr Kirk was pleased that most of the work that Cormac were scheduled to do had been done but she has requested more cutting back of the trees behind some of the bungalows. The mobile toilet that had been set up was for contractors who are installing new kitchens.
