# 218/18 CHAIRMAN'S OPENING REMARKS

Cllr Latham welcomed everybody. In line with GDPR and local government legislation; members were reminded that the Council has a general duty to consider the following matters in the exercise of any of its functions: Equal Opportunities (age, race, gender, sexual orientation, marital status and any disability) Crime and Disorder; Health and Safety and Human Rights. She asked people to speak clearly and explained that all meetings may be recorded covertly or overtly.

#### 221/18 PUBLIC PARTICIPATION

Mr Lee Manning was present to answer questions on PA18/06457

Mrs Ely spoke to the Council during the agenda item about Gunnislake Football Club during New Correspondence.

Mr David Harding addressed the Council with concerns that he has come across from looking on the website. The points addressed were:

The concept of councillors resigning and withdrawing from council business yet reappearing on committee work – no explanation is given to the electorate to explain this. The Code of Conduct was sent to the Parish Council by higher authorities.

Withholding minutes for 6 months before they come out; the publication of minutes should be a corporate responsibility.

Concern for public safety following minutes of a F&GPP meeting (which had been 'withheld') regarding a Councillor who Mr Harding described as a 'liar' and who could have put the public safety at risk— the same councillor is quoted as saying he would stand up for the developers.



This councillor has since come back onto the Committee but the reason for his return has not been given to the community members on said [NDP] Committee following the councillor's "disgusting behaviour".

An audit trail from minutes taken from a meeting on 11-04-18 states that a councillor will need to step down from council business due to family commitments if meetings continue on a Wednesday. However, subsequent minutes show her attendance at meetings that continued to be held on a Wednesday. An 'emergency' meeting was then held to 'change the rules'. Subsequent meetings, including the AGM show the councillor as being present despite these being on a Wednesday.

On 9<sup>th</sup> May the Chair was re-elected because the rules had been changed – Mr Harding questioned that there may be more information, but this has not been given under Freedom of Information – the Chair was re-elected because the rules had been changed before the AGM had taken place.

Mr Harding reminded the Council about the Code of Conduct stating there are 17 points, but he would bring to the Council's attention 5 of them. These being:

- 1. Selfishness a councillor should only be serving the public's interest and changing the night effects the efficiency of the Parish
- 2. Honesty and Integrity Mr Harding reminded the Council that a councillor had said they would show advantage to developers
- 3. Accountability membership is accountable to actions
- 4. Openness
- 5. Leadership a Chairman should lead by example to gain public confidence

Mr Harding urged the Parish Councillors to think as a member of the Parish and as a Parish Councillor and come with a system where there is more transparency.

# 225/18 NEW CORRESPONDENCE

<u>Email from Virginia Grose re The White Hart</u> – Virginia Grose alerted the Parish Council that she does not feel the business is being run properly; the ward members are aware of this and are monitoring it

<u>Gunnislake Football Club – Mrs Ely</u> – a letter from Mrs Ely had been disseminated. Mrs Ely reported that the Parish Council are being unsupportive to Gunnislake Football Club who are unhappy in their new site. She feels the Parish Council has a responsibility to ensure that the pitch at Gunnislake is useable. It was explained to her that the old Cricket Club ground at Calstock became available and the cost of making the pitch at Gunnislake was economically unviable. However, the Parish Council will invite the Gunnislake Football Club to attend a meeting.

<u>Email from Lynne Wells re letter of support for Tesco bags' funding</u> – the Parish Council were happy to support her letter requesting funding through the Tesco community scheme for play equipment at St Ann's Chapel

<u>Riding for the Disabled – request to use the green at Calstock</u> – the RDA has public liability insurance and a risk assessment but would like to use the green at Calstock – unanimous support

Cllr Tinto explained that there is now a group called the Calstock Flood Defence Partnership. Various working groups have been set up to look at issues surrounding the proposed flood defence including one which is addressing the status of the path and one looking at the design of the boardwalk/breach. Another information session is likely to be held for the public.

# 229/18 STANDING ITEM: 5 DAY PLANNING CONSULTATIONS

# Newbridge, Gunnislake

Devon will be closing the bridge at Gunnislake for an inspection and vegetation clearance. The bridge will be closed from 18-09-18-21-09-18: The Clerk is contacting Highways to ensure warning signs are placed on the Devon and Cornwall side so that vehicles have enough time to turn around.

# Wall on Newbridge Hill

Cllr Kirk has been told that this may be fixed with only 1 lane closure rather than a whole road closure.

#### Cornwall Council

Cornwall Council voted against the proposal to merge Devon and Cornwall Police with Dorset and also against the proposal to merge Launceston, Bude and Bideford into one boundary division.

# 234/18 STANDING ITEM: REPORTS FROM MEMBERS REPRESENTING THE COUNCIL ON THE COMMITTEES OR AT MEETINGS OR OTHER ORGANISATIONS

Cllr Beech reported that it has been quiet at the Delaware Community Learning Centre but the children have been using the outside tables and chairs that were gained through fundraising from Tesco.

Cllr Kirk and Cllr Latham attended the Caradon Network Area Meeting and the traffic schemes were discussed.

Cllr Polglase asked for support to explore the possibility of having free WiFi for a wider area in the village centres. **Proposal/resolution:** for Cllr Polglase to write a feasibility study to present at the next meeting (proposed: Cllr Wilkes, seconded: Cllr Wells – unanimous).

Cllr Latham reported that advice had been taken on representing this agenda item. She explained that Cllr Rooker will set out her motion and take questions. Cllr Tinto will then present his amendment and take questions. The vote for the amendment will then take place; if this is not carried the original motion will be voted on.

Cllr Rooker reported that at the last NDP Committee a motion was carried to bring the NDP – in its current draft – to the Full Council for their approval to submit it to the public for consultation. One person objected to the motion and since resigned from the NDP Committee, but all others supported the motion.

Cllr Beech told the Council that he found the document very onerous – Cllr Latham reassured the Councillors that a summary document has already been drafted for wide dissemination.

Cllr Tinto then presented his reasons for suggesting the housing target be adjusted to 'nil'. He felt not enough time had been given for debate on the issue. Cllr Tinto read from the NPFF and the Planning Inspectorate's Report to Cornwall Council and suggested that these documents would support a zero-housing allocation.

Cllr Greenwood responded and asked why Cllr Tinto had previously supported the version but had changed his mind now – the response was that the housing numbers were not available in March when it had been discussed. Cllr Beech queried where the evidence for the need is for home for Calstock parishioners. Cllr Greenwood felt that there was agreement that affordable homes are needed and that the inclusion of some open market homes is the best way to deliver these. Cllr Riggs felt that there could be a policy to say only affordable housing would be built. Cllr Woolford commented that there may not be a need now but there will be in the future and developers are unlikely to build solely affordable units. Cllr Letchford mentioned the site at Whiterocks that is all affordable, but it was pointed out that this application has now been withdrawn. Cllr Wilkes wondered whether the words "up to" could be used. Cllr Woolford felt that the numbers may need adjusting after public consultation anyway. Cllr Kirk seconded Cllr Tinto's proposal because she feels sites of solely affordable units do exist and with an AQMA in place no development should be taking place. Cllr Woolford reminded Cllr Kirk that Calstock Parish is wider than just Gunnislake village.

**Proposal:** to include an amendment that reads: with the exception of section 18 Housing Policy which is referred back to the NDP Committee for that section to be revised to reduce the baseline housing target from 60 back to nil, in accordance with the Cornwall Local Plan, which will include taking the sites referred to in NDP HP4 i) & ii) out of the plan and adjusting settlement boundaries etc to ensure that the revised policy supports the nil allocation in every respect. **Proposed:** Cllr Tinto, **seconded:** Cllr Kirk. **Vote:** 7 in favour (AT, JWe, TL, AP, DK, RR, IB); 10 objections (KL, CW, JI, GR, JR, MG, NW, JWa, RA, BH). 0 abstentions.

The proposal was rejected.



**Proposal:** remove the word 'endorse' so that the motions read to *resolve the Council to send the draft document out for public consultation* – **proposed:** Cllr Wilkes, **seconded:** Cllr Wells **Vote:** 14 in favour (KL, CW, JWe, JI, GR, JR, TL, MG, DK, IB, NW, JWa, RA, BH). 2 objections (AT, RR), 1 abstention (AP).

**Resolution:** the Council are resolved to send the draft NDP document out for public consultation.

When the second proposal was being introduced, there was some interruption from Mr Harding from the Public, who questioned whether the proposal could be made given that the last minutes from the NDP Committee had not been formally approved. However, as the motion was carried during the meeting the proposal can stand.
