#### 008/19 NEW CORRESPONDENCE

<u>Ian Read – Honicombe Manor</u> – Ian Read sent an update to say that despite ongoing communication with Cornwall Council the process of returning Honicombe Manor to 'full' holiday use is ongoing – the Council note Mr Read's correspondence.

<u>Transport Officer Cornwall</u> – Some of the bus shelters will be fitted with electronic displays. <u>Cornwall Community Governance Reviews</u> – a conference on this will be held on Saturday 16<sup>th</sup> February 2019; the Clerk has a form that she will disseminate to Councillors so that they can feedback on whether they feel there are enough councillors to represent the Parish. It was felt that Delaware now has more parishioners than Gunnislake so should have five ward members.

<u>Josh Bratchley New Year's Honours List</u> – it was suggested – and agreed - that the Parish Council should formally acknowledge Josh being named in the New Year Honours List – a letter will be written Gunnislake councillors to source an address.

<u>Definitive Map Addition Footpath 9</u> – Cornwall Council wrote to say a path from Calstock to Newton Farm has got formal designation.

#### 010/19 STANDING ITEM - CALSTOCK FLOOD DEFENCE

Cllr Tinto updated the Parish Council to say that after various discussion about the nature of the breach and whether the Tamar Community Trust would have the [financial and physical] capacity to maintain it compromise has been suggested which would entail the breach being lowered – this will require some steps and at times of very high tides may be impassable. Concerns were raised about access for disabled. The Environment Agency are likely to be submitting a planning application towards the end of this month.
