Once a plan is adopted 25% of the income raised from the levy, prior to adoption 15% is received.

Proposal/Resolution: to continue to object to this application for reasons previously cited and that it falls within the boundary of the Minerals Safeguarding Policy, there is no overriding strategic need for housing as stated in the CLP – recent figures from Cornwall Council state that Calstock Parish has a nil allocation need – and that is does not fit the description of a 'rounding-off' site, as described in the D&A Statement (proposed: Cllr Wells, seconded: Cllr Greenwood – 11 in favour, 1 abstention and Cllr Roberts did not vote).
