Proposal/Resolution: The Parish Council wish to object to this application due to over development of the site; lack of visibility, over shadowing, lack of privacy, and inadequate infrastructure in the area. Although this is contrary to the comment given on the last application the council feels that this area around St Anns Chapel has had considerable development in the last 3 years and any more would not be beneficial at all, more than 200 houses have had consent within that time frame in the immediate vicinity.
