6. PLANNING APPLICATIONS

Application PA19/00573 CALSTOCK

Description Erection of a wooden summer house on an existing old concrete plinth.

Location Ebbtide Cottage, Lower Kelly, Calstock, PL18 9RY

Applicant Mr Chris Pollard

PROPOSAL/RESOLUTION: To accept this proposal at it does not appear that it will have a damaging effect on the area, but its use should be restricted to an amenity for the family and not become a dwelling (proposed: Cllr Tinto, seconded: Cllr Greenwood – 9 in favour of supporting, 2 abstentions, 1 objection).

Application PA19/01228 GUNNISLAKE

Description Construction of two detached four-bedroom dwellings with detached double garages.

Location Land North West of Uplands, Station Road, Gunnislake

Applicant Mr R Stephens



PROPOSAL/RESOLUTION: to object to this application as it contravenes the Mineral Safeguarding Policy (December 2018) and sits within the area of Drakewalls Mine; there are also highway concerns regarding vehicular access (proposed: Cllr Wells, seconded: Cllr Greenwood – 11 in favour to object, 1 abstention).

Application PA18/09216 CALSTOCK

Description: Demolition of existing boat store/holiday let building and erection of a new detached dwelling

house

Location: Steamer Quay Lower Kelly Calstock Cornwall PL18 9RU

Applicant: Mr & Mrs Wendy & Colin Scoble

PROPOSAL/RESOLUTION: to object to this application as:

- It contravenes Cornwall Local Plan Policy 12 as the design will not be in keeping and is unlike any other building along the river bank. The size and the mass are too dense for the footprint.
- It will harm the conservation area, negatively impacting on Calstock Viaduct, a grade II listed building
- It contravenes Cornwall Local Plan Policy 24 as it will not maintain the special character and appearance of the conservation area for the following reasons:
 - o it will impact on the views from the River Tamar and the bank opposite
 - o it will impact on the view of Calstock on the train from the viaduct
 - o it will impact on the view of Calstock from at least 750m from the riverbank footpath opposite Harewood Lane into Calstock along the football field and into the Quayside
 - o it will intrude into views of the River from Lower Kelly which would be harmful
- It contravenes Policies C2 and C7 of the World Heritage Site Management Plan 2013-2018 as it would not
 add to but detract from the distinctiveness of the site and would not respect the setting and proximity of
 the river and viaduct
- It contravenes Policy HP1 and para 18.5 of the emerging Calstock Neighbourhood Development Plan which reintroduces settlement boundaries this site is outside the settlement boundary which runs along Lower Kelly and excludes any development on the riverbank side of Lower Kelly.
