## **200/20 UPDATE ON THE A390**

Cllr Wells reported that we are waiting for Cormac and Cornwall Council to formalise what was put forward last month. They are proposing four locations for speed cameras through St Ann's Chapel and Drakewalls these being mooted as being near: Whiterocks, The Rifle Volunteer pub, Wain Homes and halfway between the Primary School and the Co-op.

Cllr Wakem expressed his disgust at the time it has taken Cormac to complete work on Newbridge Hill and that there is a further delay to their finishing. Cllr Kirk felt they are carrying out very delicate work to keep the village safe and thinks that they are doing a good job under difficult circumstances and they are considering the needs of the house holders. She also said that this adds evidence that the A390 at this end is not fit for purpose.

**Proposal/Resolution:** write a letter to Geoff Brown, portfolio holder for transport in Cornwall Council to express our disappoint with this work. Proposed: Cllr Riggs, Seconded: Cllr Alford -1 abstention; one objection - all others in favour.

#### 201/20 FLOOD DEFENCE SCHEME - TAMAR COMMUNITY TRUST UPDATE

The Tamar Community Trust (TCT) and Tim Dart from the AONB have addressed the issues raised from the last meeting and these had been disseminated. Some concern was raised by TCT that they felt they were being micro-managed and criticised by the Parish Council. They assured the Parish Council that when meetings start up again representatives will be invited. The Parish Council responded to say that they were pleased with the response but felt they did have the right to pose the questions as they have a residual interest in the scheme.

#### **202/20 TOILETS UPDATE**

The Clerk has checked that the cleaning company are happy to keep working during this lockdown which they are. There have been no issues reported in the toilets although Cllr Polglase said the sign outside has got graffiti on it.

#### 203/20 CORNWALL COUNCIL UPDATE - CLLR KIRK

<u>Stony Lane</u> Cllr Kirk reported that some patching up has been done by Cormac, but it needs to be looked at again.

<u>Covid-19 Update</u> – Cllr Kirk continues to attend a weekly Covid meeting – Cllrs Flashman and Dawe have still not attended. Covid numbers are starting to increase in Cornwall and there have been some local cases.

<u>Whiterocks Development</u> – Cllr Kirk brought up the issue of how local people register an interest in the affordable units.

Delaware Ward – an extra councillor has been approved for the Delaware Ward.

<u>Community Chest Money</u>- Cllr Kirk has spent her community chest money: £500 was given to the Parish Council to help the Clerks issue information on the volunteer scheme; £1000 went to GCM for their Centenary celebrations which unfortunately were unable to go ahead but the money will hold good until September 2021 when hopefully the events will be able to take place and £500 was donated to St Ann's Chapel Community group for a defibrillator- Cllr Kirk thanked them for asking for this.

<u>Green Cornwall</u> - <u>a</u> document has been produced to look at how to make Cornwall more sustainable, but Cllr Kirk felt it missed out on connectivity with the rest of the country.



<u>Public Hall</u> – issued with a council tax bill which they do not have the funds to pay and there is a lot of administration to sort out with Cornwall Council who think the public hall is still managed by the Social Club.

<u>Dimson- Dog Bin</u> – requests have been made for a dog bin in Dimson – the Deputy Clerk will ask the workmen to complete and eligibility form for this (and the other request at Danescombe) which can then be deferred to the Amenities Committee.

#### 204/20 NEIGHBOURHOOD DEVELOPMENT PLAN UPDATE

Nothing further to report as we are still waiting to hear from the inspector.

#### 205/20 FOSTERS FIELD

The Clerk has asked for progress on this but there is nothing to report at present.

## 206/20 5-DAY PLANNING CONSULTATIONS

**PA20/06128** – Proposal/resolution: to agree with the Planning Officer and support the application as the parking issue has been addressed in the new design. Proposed: Cllr Greenwood, seconded: Cllr Beech – 3 abstentions, all others in favour.

**PA20/05827** – Proposal/Resolution: to agree to disagree with the Planning Officer as there are still concerns with increased traffic on the road. Proposed: Cllr Riggs, seconded: Cllr Wells -3 abstentions, all others in favour.

#### 207/20 FOREST FOR CALSTOCK PARISH, CROWDFUNDING PROJECT – CLLR TINTO

Cllr Tinto explained that the target has already been reached for this and over £2000 has been raised. A press release was written by the Deputy Clerk which will be published this week which may generate more money. The Crowdfunding deadline is not until the end of the month. The next stage will be to engage the community and ensure that an appropriate planting scheme is agreed in a location that is acceptable for the communities.

# 208/20 <u>GUNNISLAKE COMMUNITY MATTERS REQUEST TO TIDY UP AREA BY WILLIAM THE</u> <u>MINER IN GUNNISLAKE AND INSTALL PLANTERS</u>

**Proposal/resolution:** to agree with GCM's proposed plan to tidy up the area by William the Miner and instal planters. Proposed: Cllr Roberts, seconded: Cllr Kirk – one abstention all others in favour.

#### 209/20 FOOTPATH 5 – GUNNISLAKE, REQUEST TO INSTAL A WATER PIPE

The Parish Council had received a request from the Countryside Access Team for feedback on installing a water pipe and moving the footpath. Sarah Ashley spoke of her concerns regarding this request and feels it will lead to a business venture which will impact on the highways, hedgerows etc. The Footpath Society also had concerns about large vehicles accessing the lane and churning up hedgerows etc. There is ambiguity about who owns the track. These concerns will be fed back to the Countryside Access Team.



#### 210/20 VOLUNTEER SCHEME UPDATE

The Deputy Clerk reported that she has contacted all volunteers on her database and has enough people offering help again to re-publicise the scheme which she has done. The Clerks were thanked for their work on this.

#### 211/20 CALSTOCK CAR PARK WALL REPAIR - QUOTES

The Deputy Clerk had included two quotes in the associated information that was sent out. Quote A was for £1430; Quote B was for £1902. **Proposal/Resolution:** to accept the quote of £1430 – proposed: Cllr Riggs, seconded: Cllr Tinto – 5 abstentions all others in favour.

#### 212/20 REMEMBRANCE SUNDAY FEEDBAK

Cllr Kirk and Wakem attended the scaled back service. They thanked the Deputy Clerk for organising this and said it had gone well and thought had been given to health and safety issues due to Covid and everyone present had adhered to these. Other people said it was good having a livestream and hoped that this could take place each year – the Deputy Clerk to extend the Council's thanks to Hilary Fairhurst and Debbie Crocker for the time they took in helping to prepare for the service.

#### 213/20 PLANNING COMMITTEE PA20/03516 UPDATE - CLLR KIRK

Cllr Kirk reported that this application was refused at Cornwall's Planning Committee. She was disappointed to have to represent both Cornwall Council and the Parish Council and she had expected someone from the Parish Council to attend. Cllr Kirk was thanked wholeheartedly for addressing this issue and getting a positive outcome for local residents.
