**Proposal/Resolution**: to object to this application because in the application's planning statement, NPPF paragraph 59 is referred to as a policy to boost housing stock. In this parish there has been an oversupply of housing since 2016 when the housing allocation in the Cornwall Local Plan was cited as nil. There have been over 300 approvals since. The Parish supports local businesses and recognises tourism as a key boost to the local economy – as factored into the emerging NDP (policy LET 2).
