#### 141/21 STANDING ITEM – CORNWALL COUNCIL REPORT – CLLR KIRK

Councillor Kirk informed the Council of the following:

<u>**River Walk – Gunnislake</u>** - CORMAC have erected bollards the length of the ditch on the river path from Newbridge downstream to prevent further vehicular accidents.</u>

**Cornwall Housing** have been inspected for performance and have been found inadequate with regard to their repairs programme. This has been my experience and I have had to intervene on a number of occasions: Residents in a bungalow with elevated radon levels had been waiting for a radon pump and sump for 3 years when they contacted me, but since I intervened have had a system installed. Bungalows streaming with damp have had to wait quite unacceptable lengths of time before the matter has been addressed. One house with water coming up through the floor was evacuated in February and works to install a membrane finished only last week. The negative report has led to a promise of better and more rapid action. I shall keep a watching brief.

I still have no news about **<u>Bridge View Nursery site</u>**. I believe the drainage plans have still to be approved, notified today that soakaways have been approved.

**Cornwall Council** had a proposal for a Housing emergency motion which was referred to cabinet.

**<u>Cornwall Council</u>** - Cornwall Climate Emergency – amendment support Government's climate bill, two merged but defeated by 33 to 39 by Conservative majority.

I have also attended a meeting with Luke Pollard MP for Plymouth re radioactive water discharge into Hamoaze from the Dockyard

<u>Annex</u> <u>1</u> – Public Participation Bethany Read Item 8 Definitive Map Modification Order – Newton and Lower Metherell

Ms Read spoke on behalf of the family who own the land in question. She told the council about the history of the land including the fact that Mr Cundy who originally owned the land had never authorised the public to use the land as a footpath. There are no mentions of a footpath on deeds dating back to 1920 or on any further deeds. A land registry search also bears no mention to a footpath.

Over a 100 years ago a path was used by local workmen including those at Cotehele and the postman, this was by licence by the owner at the time. There are cattle grazing in the land and Mr Cundy used to let friends use the path occasionally but only by permission and any others were challenged as this is private land.

In 2007 an application was made by the Ramblers Association, and it was stated that Mr Cundy had shown intent that this could be a right of way, this is not true and he never wanted it to be made public. There is an issue of safety with bullocks in the field and the cost this would put on the family to make the footpath open to the public would not be viable. There are alternative routes that can be taken. Cllr Roberts spoke to the council and informed them that he had permission in the past from Mr Cundy to shoot on the land but only when he had permission and he would not have been allowed to use his air rifle if this was a public footpath.

Dougal McLachlan a local parishioner also stated he had permission to use the land for vermin control specifically from Mr Cundy. Also, in his previous role working for Cornwall Council he state that in 1946 the Definitive map was updated and this path does not appear on it and has not since.
