5. NEIGHBOURHOOD DEVELOPMENT PLAN – REFERENDUM RESULT AND MATERIAL CONSIDERATIONS

Cllr Tinto spoke regarding the referendum result and how pleased he was that it was such a successful outcome for all involved and wished to thank the council and the NDP committee for all its support over time. Out of all the votes 80% of those who voted, voted for the plan. At 1154 on the 21st January he was emailed by Colleen O'Donnell the Senior Development Officer/Planning Policy telling him that the Plan was successful and carried full weight. He suggested producing a summary of the Policies for the Planning committee, which the chairman agreed with, and maybe some training sessions afterwards. The chair agreed on the synopsis but wanted to wait until after that had been produced before agreeing to training. He also said in order to take the NDP forward there would need to be monitoring of the plan and a review of the comments made. He would also like to engage with Housing Associations over rural exception sites. He suggested at the next committee meeting that he would propose a sub committee to look at those issues.
