## Planning Application Ref: 01327/22/FUL - GULWORTHY

Applicant: Mr S Taylor - Zip World Limited

Description: READVERTISEMENT Provision of a gravity-fuelled Alpine toboggan ride & upgraded rope &

nets course, open space & additional car parking spaces

Address: Tree Surfers Tavistock Woodlands Gulworthy

Several members of the public raised a number of concerns about this application, the Tamar Valley AONB Manager also raised queries.

Proposal/resolution: there are concerns regarding:

- contamination;
- ecology (in particular bat roosting and flight paths), the removal of trees,
- the tranquillity of local residents and current users being compromised,



- the setting of the site within the AONB, WHS and the schedule of ancient monuments (arsenic workings),
- the potential pollution of the river at a point where the water should be extracted for drinking,
- the increase in the amount of traffic going through the village of Gunnislake which already has a an Air Quality Management Plan and extremely high levels of emissions due to the vehicular movements,
- the pressure on Newbridge bridge at Gunnislake,
- the lack of sustainability travel and integrated access to and at the site
- the visual impact and interruption to wildlife with the lighting of the feature and the operating times
- the impact of drainage

With these concerns in mind and no supporting evidence to suggest such issues have been considered in detail Calstock Parish Council objects to this application. Proposed: Cllr Wilkes, seconded: Cllr Tinto – unanimous.
