# 10. ACCOUNTS UPDATE

Two queries were made:

The actuals precepts receipts were a minus figure (£51.572) and the received donations and grant figure was £31,000. This was explained because the minus figure was inputted incorrectly and put into the Finance heading instead of being divided up into the relevant committees – this will be rectified next year and £30,000 of the £31,000 was given to us by Cornwall Council to look after for the Tamar Community Trust and the £1000 was CIL money received from developments.
