However Cllr Kirk had said she felt the grounds for refusal were not material considerations and a local business should be supported. She wished to call it in to Committee. There was divided opinion from Councillors present but both Cllr Wakem and Cllr Flashman (if available) would be willing to support Cllr Kirk should it be heard at Cornwall's Planning Committee. It was felt that it would be an interesting exercise to see which local policy had the stronger argument at Cornwall Council leve.
