Proposal Erection of single detached dwelling Location Land Rear Of Treleigh, Drakewalls

Proposal/resolution: the Parish Council felt the design was good with off-road parking. The dwelling would not overlook other properties and is within the Settlement Development Boundary of the Neighbourhood Development Plan, however the Council objects to it as the dwelling will need to be connected to the sewage system which is already over capacity and seemingly cannot cope with the current demand put on it with many spills and discharge of sewage into the water courses and ultimately the River Tamar.
